## Rules

1. Boat owner must carry a minimum of \$100,000 liability insurance coverage
2. Tournament Director may alter fishing times if unsafe conditions warrant
3. Tournament Director may establish "off limits" areas
4. No fishing within 50' of another competitors anchored boat
5. Good sportsmanship is expected of all contestants
6. Littering or polluting of any kind will not be tolerated
7. Alcoholic beverages and/or illegal drugs or a contestant deemed impaired shall not be allowed during the tournament or weigh-in period
8. Only artificial lures may be used. No live or prepared bait will be permitted
9. Only one rod may be used at a time
10. Trolling by using the outboard motor as a fishing method is not permitted.
11. All combustion motors must be equipped with a "Kill Switch" device and the connected to the boat operator when the combustion motor is running.
12. Each boat must be equipped with adequate live well
13. Maximum horsepower cannot exceed the horsepower limitations listed for the watercraft as set by the U.S. Coast Guard
14. No boats with stick steering boats allowed
15. Only bass alive, as determined by the Tournament Director, are eligible for Big Bass award.
16. Penalties – 1 pound for dead and short fish
17. Teams that do not check-in by designated time will not have their fish weighed.
18. A Coast Guard approved life preserver must be worn whenever the combustion motor is in operation
19. Ties shall be determined by the:
  - a. Largest number of legal fish
  - b. The heaviest one bass
  - c. Coin toss or if contestants agree to split the amount of the payout of the tied positions
